I Submit this application for membership to the Boothbay Farmers' Market. This membership entitles me to rent a stall space at the market.

Membership shall be open to all without regard to race, color, sex, sexual orientation, gender identity, age, physical or mental disability, religion, ancestry or national origin. The membership reserves the right to accept new members by a majority vote. A new member may be accepted as a provisional member or a part-time member, neither of whom has voting rights. After 1 year as a provisional member, the market membership will vote on provisional members becoming full-time members with voting rights. A part-time member rents a temporary space at a rate of \$40 (*forty dollars*) per four consecutive week period.

Payment for the market can be submitted at any time and new members will be voted on once a year at the March meeting for the current season. All applications must be submitted no later than March 1 to be considered for the current season. Upon acceptance to the market, proof of liability insurance and copies of state and municipal licenses which pertain to your product must be provided to the market president.
